A6 VOLUME A: BACKGROUND AND NEED Public Engagement



6.1 Introduction

As the operator of Brisbane Airport, Brisbane Airport Corporation (BAC) has a responsibility to ensure the airport operates efficiently, while limiting its impact on surrounding communities. As part of the Environmental Impact Statement and Major Development Plan (EIS/MDP) process for the New Parallel Runway project, a comprehensive Public Engagement Program (PEP) was developed with the aim of informing and educating the public about the project.

Requirements for public engagement are included in legislation and within the EIS Guidelines. The PEP aims to fulfil and, where possible, exceed the engagement requirements under the *Airports Act 1996*, the *Environment Protection and Biodiversity Conservation Act 1999* and the EIS Guidelines prepared for the New Parallel Runway project.

The preparation of the Draft EIS/MDP is a complex project that integrates a wide variety of technical information. It is recognised that this level of complexity may act as a disincentive to broad-based public engagement due to the sheer size of the Draft EIS/MDP and the use of extensive technical explanations, jargon and complex diagrams. It is BAC's responsibility to provide the Draft EIS/MDP to the community in a way that breaks down barriers to communication, promoting understanding and readability, while maintaining the overall integrity of the information.

6.2 The Public Engagement Program (PEP)

The PEP for the New Parallel Runway project is designed to inform and educate the community about the project, while providing opportunities for the community to participate in and comment on the Draft EIS/MDP process. The objectives and methodology of the PEP are discussed in this section.

6.2.1 Objectives of the PEP

The objectives for the PEP are:

• Develop an understanding among the community about the purpose and process of the EIS/MDP.

- Educate and inform the community about relevant technical aspects of the project and their likely impacts.
- Provide sufficient opportunities/activities for all people and groups to receive information and provide feedback on the Draft EIS/MDP.
- Ensure materials developed to support the PEP are clear and consistent in their messages.
- Respect the rights of the community to voice their opinions and to have those opinions considered in the development of the Draft EIS/MDP and any mitigation strategies.
- Nurture a cooperative, information-led relationship between BAC, the EIS/MDP team and the community.
- Review and refine the engagement strategy at regular intervals in accordance with feedback from the community.
- Ensure that views expressed throughout the engagement process are considered in the relevant reports so that interested parties can see how their ideas have been incorporated into the findings and recommendations.
- To provide the Social Impact Assessment team with feedback to inform the SIA section of the Draft EIS/MDP (see Chapter B12).
- Provide as part of the Draft EIS/MDP documentation a concise engagement report that accurately reflects the views of those consulted.

6.2.2 Methodology

To meet the objectives of the PEP the umbrella approach to public engagement is to:

- Keep all information as simple as possible without sacrificing its integrity.
- Select communication formats suitable to a wide range of people and groups.
- Make information available in a timely manner.
- Provide adequate channels for community feedback.

• Ensure feedback from the community flows through to the EIS/MDP team for consideration in preparing reports and developing management and mitigation strategies.

A phased approach was taken to the development of the PEP to ensure appropriate engagement activities were undertaken for relevant project milestones. This section describes the methodology used to design the PEP.

6.2.2.1 PEP Stages

There are two distinct phases during the EIS/MDP process for the New Parallel Runway project:

- Phase 1 Engagement activities undertaken prior to the release of the Draft EIS/MDP.
- Phase 2 Engagement activities undertaken after the release of the Draft EIS/MDP.

The activities associated with each phase of the PEP are outlined in **Table 6.2.**

6.2.2.2 The PEP Scope

The PEP has been designed to offer engagement opportunities to people and groups who may be affected by, or have an interest in, Brisbane Airport and the New Parallel Runway project. The scope for the PEP has been determined by two means:

- Proximity to Brisbane Airport a radial approach has been taken to identify people and groups living and/or working within a 20 km radius of Brisbane Airport. This was undertaken with the understanding that people living and/or working closer to the Airport are more likely to be affected by the New Parallel Runway project in some form and/or take an active interest in the project. As outlined in Figure 6.2, residents living and/or working within a 20 km radius of Brisbane Airport have been broken into groups related to their proximity to the Airport (within 5 km, 5 to 10 km, etc.). The same approach was taken in relation to the proposed dredging activities at Middle Banks in Moreton Bay.
- Interest in particular issues associated with the New Parallel Runway project – people and groups from many different geographic locations and positions within the community will have an active interest in the New Parallel Runway project. The areas of interest will be related to:
 - Land based activity on Airport land and its surrounds.
 - Activity in Moreton Bay.
 - Activity in the air above Brisbane.




To further tailor PEP activities to people and groups identified by these two means, a number of involvement levels were identified and allocated to those people and groups identified. These levels are:

- Level 1: Groups and individuals that have an active interest in the issues/project or are potentially directly impacted physically, socially or financially.
- Level 2: Groups and individuals who will have an active interest in the engagement activities around a specific issue related to a project.
- **Level 3:** Groups and individuals who will have only a general interest in a project, further described as people who want to know broadly what is being considered and decided.

PEP activities are designed to meet the information requirements of people and groups within each involvement level. The list of interested people and groups addressed in the PEP has been analysed in section 6.3 in accordance with the anticipated level of involvement and the specific topics that are likely to be of interest to these people and groups.

6.2.2.3 Stakeholder Identification

The stakeholder identification process was a critical first-step in developing the PEP. This process identified individuals, groups and organisations from the community that would be interested in the EIS/MDP process for the New Parallel Runway project. The PEP is designed to reach these stakeholders.

The identification of stakeholders has been facilitated through a number of sources including:

- A workshop with BAC's New Parallel Runway Core Project Team held at BAC offices on 25 May 2005.
- Supplementary Report to the BAC 2003 Master Plan, which brought together the outcomes of the 90 day public comment period subsequent to the publication of the 2003 Master Plan

 Draft for Public Comment and included comprehensive details of people and groups involved.
- BAC's stakeholder and contacts database.
- Detailed search of the internet, including searches of websites linked to identified people and groups.
- Desktop research of suburbs within the vicinity of the Airport to identify education and health facilities including schools, pre-schools, libraries, aged care centres and hospitals.
- Ongoing identification of stakeholders through PEP activities during the EIS/MDP process.

The database of stakeholders has been built upon since its establishment in June 2005, as a result of engagement activities such as community newsletter surveys, calls to the 1800 number, email enquiries and general contact with the community. In all cases, stakeholders have been asked for their permission to be entered to the database.

6.2.2.4 Monitoring and Evaluation

Monitoring and evaluating the outcomes of the PEP is an important component of refining engagement activities to ensure they respond to the needs of the community, while also determining whether reach is being achieved. Evaluation and monitoring mechanisms are included in the PEP to determine:

- Whether objectives were achieved and to what level these were achieved.
- Which engagement tools and techniques attracted the greatest level of response.
- The extent to which identified people and groups participated in the program.
- The degree to which community feedback played a role in the decision making.
- Whether the community felt that they were listened to and were adequately able to express their views.

Evaluation methods outlined in the PEP include:

- Regular review and analysis of feedback received through the 1800 number, enquiry email, newsletter-based surveys, briefing sessions and presentations, allowing for quantitative and qualitative evaluation.
- Community research to evaluate knowledge and understanding of the EIS/MDP process and the choice and content of communication tools, to determine the quality of the overall PEP.
- Meeting with identified key government stakeholders to determine levels of personal and constituent satisfaction with the PEP.
- Peer review and evaluation of the program.
- Monitoring and analysis of media reports.

6.3 Identified Stakeholders

The following table provides details of identified stakeholder groups addressed by the PEP.

6.4 Engagement Tools

A number of engagement tools are used in the PEP for the New Parallel Runway project to provide opportunities for BAC to reach and inform the public, and for the community to participate in and comment on the Draft EIS/MDP. These tools are described below. Their use within the PEP is detailed in sections 6.5 and 6.6.

6.4.1 Briefing Sessions

Briefing sessions are included in the PEP to ensure relevant persons and groups are informed about the EIS/MDP process. Key members of the Core Project Team conduct these briefings in either an individual or group setting.

6.4.2 Information Kits

Information kits are provided at all briefing sessions. These kits contain copies of engagement materials, such as fact sheets and newsletters, a project briefing document and relevant contact cards.

6.4.3 Information Line

The freecall 1800 information line is included in the PEP as an enquiry and feedback source for the community during the EIS/MDP process. The information line phone number is published widely and is staffed between 9.00am and 5.00pm Monday to Friday, with a message bank available to take messages after hours. The information line is staffed by members of the Public Engagement Team who have the available information to answer most questions posed by members of the community. Where questions of a technical nature arise that cannot be answered immediately, details of the guery are taken and a response provided as soon as the information is available. All calls to the information line are logged in the project database (see Appendix A6.1 for database of community contacts).

For the duration of the public comment period, provisions have been made to handle a large volume of calls with the establishment of a call centre at Banksia Place, Brisbane Airport. The call centre will operate extended hours at the commencement of the public comment period.

6.4.4 Enquiry Email

A project specific enquiry email address is included in the PEP to facilitate community enquiries. Info@bacnpr.com.au is advertised widely in engagement materials as a key contact point for the community. Enquiries sent via email are answered in a timely manner.

Details of email contact are logged in the project database (see **Appendix A6.1** for database of community contacts).

6.4.5 Community Newsletters

Community newsletters have been included in the PEP for the EIS/MDP process. These are developed and distributed via appropriate means to reach relevant people and groups. Distribution mechanisms for the newsletter are through local newspapers, by placement in local libraries, direct mail to the project database (post or email) and display at airport terminals (domestic and international). The newsletters are produced in both hard copy and online formats (see **Appendix A6.3**). A feedback form is included with each newsletter to gather community feedback related to the EIS/MDP process.

6.4.6 Website

The New Parallel Runway project website is an important engagement tool included in the PEP for the EIS/MDP process. The project specific site contains detailed information related to the EIS/MDP process, a library of communication materials such as fact sheets and newsletters, links to relevant sites, a glossary of commonly used aviation terms and media releases related to the project from both BAC and other sources.

6.4.7 Community Research

A community research program is included in the PEP for the EIS/MDP process to inform BAC of the information needs of the community, identify emerging issues and to provide information for the EIS/MDP process. Formal and informal feedback is collected to meet these needs. Outcomes from this research can be found in section 6.5.3.



6.4.8 Print Advertising

Print advertising activities are included in the PEP as a means of communicating with the community regarding aspects of the project. Formal print advertising is included in the PEP to coincide with key milestones during the EIS/MDP process. See **Appendix A6.3** for copies of print advertising.

Print advertising is included in the PEP to:

- Formally advise the community of the release of the Draft EIS/MDP, where copies are available for viewing or purchase and inviting formal comments during the 90 day period in accordance with the requirements of the *Airports Act 1996.*
- To advise the community of the times and locations of information sessions, displays and other engagement activities as well as the locations of copies of the Draft EIS/MDP for viewing.
- To advise the community of the pending end of the public comment period around 14 days before closure.

6.4.9 Media Activity

Throughout the PEP for the EIS/MDP process the media is utilised to disseminate information related to the project to the community. See **Appendix A6.3** for copies of media releases.

6.4.10 Draft EIS/MDP and Supporting Documents

The Draft EIS/MDP is a complex document that integrates a wide variety of technical information across a number of specialist fields. A number of display locations are outlined in the PEP as places where the community can view the Draft EIS/MDP document during the public comment period. The document is also produced on CD ROM and is available online.

It is recognised that the complexity and size of the Draft EIS/MDP may restrict members of the community from participating in the public comment period. To make reading and understanding the Draft EIS/MDP more accessible to the community, two supporting documents are included in the PEP to give an overview of the major outcomes of the Draft EIS/MDP.

These are:

- Summary of Major Findings a document that gives an overview of the Draft EIS/MDP with a particular focus on communicating the major outcomes and findings.
- Flight Path and Noise Information Booklet a document that shows flight paths and noise contours. This also contains a section on how to read and interpret these charts.

6.4.11 Fact Sheets

Fact sheets are included in the PEP to inform and educate the community about aspects of the EIS/MDP process. These are available in hard copy or in electronic format online. Fact Sheets also form a major part of the Information Kit that is distributed at briefing sessions. See **Appendix A6.3** for samples of fact sheets.

6.4.12 Contact Card

Contact cards are included in the PEP to give community members contact details for the project team. A general contact card with the freecall 1800 number, email address and the reply paid postal address is designed for members of the community.

6.4.13 Information Sessions, Public Displays and Events

Public displays, information sessions and events are included in the PEP to provide the community with access to the information contained within the Draft EIS/MDP during the public comment period.

• Information sessions

Information sessions provide a forum where community members can learn, ask questions and provide feedback about the project. The findings of the Draft EIS/MDP are communicated to attendees via poster displays, audio visual presentations, computers, expert consultants and reading areas set up with copies of the Draft EIS/MDP.

Public displays

Public displays are included in the PEP for the EIS/MDP process to inform the community of the release of the Draft EIS/MDP and the opportunity they have to comment on the document. Displays will be held in shopping centres and other community facilities.

A staffed static display will also be set up at Banksia Place, Brisbane Airport for the duration of the public comment period. Members of the community will be able to visit this Community Information Centre to read the Draft EIS/MDP, use Transparent Noise Information Package (TNIP) software, view poster displays and ask questions about the project.

Events

A number of community events have been included in the PEP to inform the community about the progress of the project.

6.4.14 Project DVD

A DVD has been produced for the public comment period. The main presentation on this DVD is a 30 minute overview of the outcomes of the Draft EIS/MDP. The DVD will be used during a variety of engagement activities in the period, such as at information sessions, in the Community Information Centre and for general distribution to members of the community.

6.5 The Public Engagement Program - Phase One July 2005 - September 2006

Phase One of the PEP focused on preparing the community for the release of the Draft EIS/MDP. A number of engagement activities were undertaken during this time to commence informing the community about the EIS/MDP process for the New Parallel Runway project.

Activities undertaken during Phase One are detailed in this section. This section also contains community responses to these activities, the findings of research undertaken to determine community interest, knowledge and understanding of the project and how BAC has responded to community feedback by altering or adding engagement activities to the PEP for the EIS/MDP process.

6.5.1 Public advertising of EIS Guidelines by DEH (2 July 2005 – 21 July 2005)

While communication during this time was conducted through DEH, BAC provided support using a range of information channels (see **Table 6.5a**). The information given to the community defined the EIS/MDP process and the reasons for the process, providing mechanisms through which BAC could inform the community about the EIS/MDP process and the community could provide feedback on the process.

A number of information requirements for the community were identified for this period, including:

- An overview of the proposed New Parallel Runway project background and need.
- Details about the EIS/MDP process, why it is undertaken, who initiates the process and the roles that various parties take in the development of the EIS/MDP.
- The role of the EIS Guidelines.
- An overview of the EIS/MDP process including anticipated timing and description of next stages following approval of EIS Guidelines by DEH.
- How interested parties can be involved in shaping the EIS Guidelines, including contact details for DEH.
- Who the community could contact at BAC for further information.

6.5.1.1 Engagement activities for the public advertising of EIS Guidelines by DEH

To support DEH's advertising of the draft EIS Guidelines, the following engagement activities were undertaken in conjunction with DEH by BAC to notify the community about the public comment period for the guidelines. BAC also commenced informing, educating and providing feedback mechanisms for the community in regard to the formal planning for the New Parallel Runway project.

6.5.2 Approval of EIS Guidelines, completion of all impact studies and preliminary project design and compilation of Draft EIS/MDP (September 2005 – September 2006)

A broad range of engagement tools were utilised during this period to reach as many members of the community as possible to inform and educate them about the EIS/MDP process.

A number of information requirements for the community were identified for this period, including:

- An overview of the proposed New Parallel Runway project.
- An overview of the Public Engagement Program for the EIS/MDP process.
- Details about the EIS/MDP process, why it is undertaken, who initiates the process and the roles that various parties take in the development of the EIS/MDP.

- An overview of the EIS/MDP process including anticipated timing and description of next stages following approval of EIS Guidelines by DEH.
- An outline of major elements of the EIS/MDP divided into four information categories (Project Need and Background, Airport and Surrounds, Middle Banks, Moreton Bay and Airspace).
- Who is undertaking the studies for the EIS/MDP.
- How the community can contact the project team to ask questions and provide feedback.
- An explanation of feedback processes.

6.5.2.1 Engagement activities prior to the release of the Draft EIS/MDP

The following activities, as outlined in **Table 6.5b**, were undertaken to continue informing, educating and providing feedback mechanisms for the community in regard to the New Parallel Runway project.

• The role of the EIS Guidelines.

6.5.3 Outcomes of community research and feedback

The PEP was designed to ensure the community had numerous opportunities to provide feedback on the EIS/MDP process for the New Parallel Runway project. The outcomes of the various feedback and community research mechanisms for Phase One of the PEP are discussed below. The summary of outcomes covers the period 2 July 2005 – 1 September 2006.

6.5.3.1 Community feedback

Community feedback has been gathered through interaction with the community regarding the EIS/MDP process for the New Parallel Runway project.

Feedback for Phase One was gathered from the community via:

- 1800 information line
- Email enquiries
- Briefing sessions

1800 information line

• 150 calls have been logged on the 1800 information line to 1 September 2006.

Email enquiries

• 64 emails have been received on the enquiry email info@bacnpr.com.au to 1 September 2006.

Briefing sessions

• 115 people or groups have briefed on the project up to 1 September 2006.

6.5.3.2 Community research

Community research was undertaken to gather both quantitative and qualitative data related to the EIS/ MDP process for the New Parallel Runway project.

Community research undertaken to gather community feedback via:

- Self completion feedback surveys
- Random telephone surveys
- Focus groups

Self completion feedback surveys

Self completion feedback surveys forms were distributed with each round of the Community Newsletter during Phase One of the PEP. The results of this research are detailed in this section.

Self completion feedback surveys #1 (survey period 1 – 24 February 2006)

683 responses were logged during this period. **Figure 6.5a** shows the number of survey responses by postcode.

Categories of interest

Respondents were asked to nominate a project category of most interest.

- Airport and Surrounds 40% of responses
- Airspace 28% of responses
- Project Need and Background
 16% of responses
- No category of interest recorded 9% of responses
- Middle Banks, Moreton Bay
 7% of responses

Project benefits

Respondents were asked if they saw any potential benefits related to the project. These were then coded into categories for reporting purposes.



Respondents were asked to nominate project categories of most interest. Some respondents have indicated an interest in more than one project category.

Project benefits

Respondents were asked if they saw any potential benefits to the community related to the project. These were then coded into categories for reporting purposes.

- Economic development, in the region (29 percent) or for the future (11 percent) were the main benefits mentioned by respondents.
- One quarter of the respondents either did not know (10 percent) or did not answer the question (15 percent).

Respondents were asked if they saw any potential benefits to themselves or their family related to the project. These were then coded into categories for reporting purposes.

- More flights into and out of Brisbane was the main personal/family benefit identified by Community Newsletter respondents (12 percent).
- Greater efficiency and safety (7 percent), easier access to/from Brisbane (6 percent) were also mentioned by respondents.
- Five in ten either did not know (23 percent) or did not answer the question (29 percent).

Project impacts

Respondents were asked if they saw any potential impacts related to the project on their household. These were then coded into categories for reporting purposes.


- Increased noise over residential areas was mentioned by 39 percent of respondents.
- This is a similar proportion to the February phase of research (42 percent in February 2006).
- A proportion of respondents believe the impact will be minimal (5 percent), or that there will be no impact (13 percent).

Random telephone surveys

Random telephone surveys were conducted in February and June 2006 during Phase One of the PEP to determine the level of reach of newsletters in community newspapers and as an additional mechanism to secure responses to questions posed in the survey contained in the community newsletter. 300 random telephone surveys were conducted in February and again in June with respondents drawn from the northern (100), southern (100) and western (100) suburbs of Brisbane. The additional information from this survey adds depth to the feedback received from the newspaper and on-line surveys.

Results from telephone survey #2 – June 2006

Awareness of the New Parallel Runway project

72 percent of respondents stated they were aware of the New Parallel Runway project when asked during the telephone survey.

Awareness of the Community Newsletter

39 percent of respondents had seen the New Parallel Runway community newsletter in their Quest Newspaper when asked during the telephone survey.

Response to the New Parallel Runway project

- 81 percent of respondents agree the NPR is necessary given the increasing South East Queensland population.
- 67 percent of respondents agree it will make a significant contribution to the business community.
- 54 percent of respondents agree the benefits will be felt amongst the general community.
- 60 percent of respondents disagree that the NPR will have a negative impact on them personally.

Categories of interest

Respondents were asked to nominate a project category of most interest.

Project benefits

Respondents were asked if they saw any potential benefits related to the project for the community. These were then coded into categories for reporting purposes.

- Economic development in the region was more likely to be mentioned by Northern residents (31 percent) and least likely by Southern suburb residents (8 percent).
- Those previously unaware of the NPR project were more likely to feel there would be no benefit to the community from the project (20 percent compared to 8 percent amongst those previously aware).
- Those people primarily concerned about 'Airspace' as an EIS/MDP category were significantly more likely to consider the project brought no community benefit (18 percent).
- Airport users consider the greatest benefit to be more flights into and out of Brisbane (36 percent).

Project impacts

Respondents were asked if they saw any potential impacts related to the project. These were then coded into categories for reporting purposes.

- Most (73 percent) residents consider there will be no impact on their household from the development of the NPR. This appears to have increased from 60 percent of residents in February 2006.
- Residents of the Northern suburbs are least likely to feel there will be no impact on them from the project:
 - North (65 percent no impact)
 - South (71 percent no impact)
 - West (83 percent no impact)

Focus group sessions

Focus groups were held to provide BAC with feedback on the quality of various engagement tools and to assist in identifying key issues within the community. The focus groups were also posed with questions similar to that contained in the survey, adding further depth to results. Results from focus groups were provided to the Social Impact Assessment team (see Chapter B12).

Focus groups sessions #1 – March 2006

Three focus groups were held with 33 participants in February 2006. These groups were formed with residents from northern, southern and western suburbs.

Project benefits

Discussion of project benefits centred on the following topics:

- More efficient airport the project will result in more travel options and faster flying times. The proposed runway will further improve what was seen by many participants as a very convenient airport compared to those interstate.
- **Improved tourist facility** the project will provide overall benefits for the tourism industry with flow on effects to the Queensland economy.
- Safety this aspect was discussed in terms of having a back up facility, in the case of emergencies.
- **Reduced air emissions** there was a general perception that the project will assist in reducing air emissions as there will be less congestion in the air coupled with more efficient aircraft being developed in the future.

Project impacts

Discussion of project impacts centred on the following topics:

- Flight paths further information needs to be provided before the community can make any meaningful assessment of the project and the personal impact of it.
- Air emissions there was a mixed reaction to this area of concern, with some participants believing that the project could result in reduced air emissions, as aircraft would not be required to be in a holding pattern during peak periods. Others highlighted this as an impact; commenting that any emissions will have personal health and environmental impacts.
- Supporting infrastructure discussion focused on roads in and around the Airport and the need to undertake complementary upgrading to ensure congestion is eased getting to and around the Airport.
- Environment participants discussed issues such as mangrove habitat loss, dredging in Moreton Bay, and the impacts of the project on flora and fauna.
- Noise and vibration this was a common concern for those participants living in proximity to the Airport and flight paths.

Focus groups sessions #2 – June 2006

Three focus groups were held with 19 participants in June 2006. These groups were formed with residents from northern, southern and western suburbs.

Project benefits

Discussion of project benefits centred on the following topics:

- Regional growth the project was seen as a necessity by most given South East Queensland is among the fast growing regions in the world.
- **Economy** the project will provide an economic boost for the region.
- **Jobs** the New Parallel Runway will provide increased job opportunities for the region.

• **Tourism** – the project was seen as being good for tourism in the region allowing more people to travel to Brisbane and the people of Brisbane to travel more easily.

Project impacts

Discussion of project impacts centred on the following topics:

- Flight paths concerns were raised about increased numbers of aircraft using Brisbane Airport. Once again further information needs to be provided before the community can make a decision about the impact.
- **Noise** related to flight paths. There were concerns over the amount of noise new flight paths would cause over residential areas.
- Air pollution some concerns were raised about the amount of air pollution created by increasing numbers of aircraft in the skies over Brisbane.
- Environmental damage concerns were raised over the environmental impact of the construction of the new runway both on Airport land and in Moreton Bay.

6.5.4 Outcomes

A number of outcomes for the PEP have come about based on community feedback and research results. Changes have been made to address specific issues that arose during Phase One of the PEP to ensure the engagement activities planned for Phase Two, during the public comment period, address the needs of the community in relation to the New Parallel Runway project. These are discussed below in relation to general engagement activities and then specific areas of the EIS/MDP.

6.5.4.1 General engagement activities

Community feedback has informed a number of actions for general engagement activities. Changes were made during Phase One of the PEP:

 Changes were made to the BAC homepage after community feedback showed that the link to the New Parallel Runway section was difficult to locate.



 Fact sheet #13 – Frequently asked questions and answers (see Appendix A6.3) were developed to answer questions frequently asked of the project team.

6.5.4.2 Project Need and Background

Community feedback has informed a number of actions for the PEP in the area of Project Need and Background:

• Due to community interest in runway options that have been explored to date, an article about runway options, with images of alternative runway configurations that have been explored, was included in Community Newsletter #2 (see **Appendix A6.3**).

6.5.4.3 Airport and Surrounds

Community feedback has informed a number of actions for the PEP in the area of Airport and Surrounds:

- Road infrastructure in the vicinity of the Airport has been raised as a significant issue through community feedback. As a result the New Parallel Runway Project Engagement Team held meetings with the community relations teams from Brisbane City Council and the Queensland Government to better understand the wide range of road infrastructure projects being undertaken at the moment.
- Fact sheet #10 Important roads to service Brisbane Airport and surrounds was developed and distributed to the community in response to interest in road infrastructure around the Airport (see Appendix A6.3).
- Fact sheet #11 Bird management at Brisbane Airport was developed and distributed to the community in response to interest in bird management practices at the Airport (see Appendix A6.3).
- Fact sheet #12 Constructing a New Parallel Runway at Brisbane Airport was developed and distributed to the community in response to queries about the time for construction and operation of the new runway (see Appendix A6.3).

6.5.4.4 Middle Banks, Moreton Bay

Community feedback has informed a number of actions for the PEP in the area of Middle Banks:

 Fact sheet #14 – Runway site preparation with sand from Middle Banks, Moreton Bay was developed in response to community enquiries about the process of dredging and placing sand on the Airport site (see **Appendix A6.3**).

6.5.4.5 Airspace

Airspace has been highlighted by community feedback as an area of particular interest to the community. A number of actions have been undertaken for both Phase One and Phase Two of the PEP:

- Community Newsletter #2 focused on Airspace to give the community information prior to the release of the Draft EIS/MDP. It discussed how flight paths and noise will be illustrated once the Draft EIS/MDP is released (see **Appendix A6.3**).
- Fact sheet #9 Operating with two parallel runways was developed in response to community enquiries about operational modes with the New parallel Runway (see Appendix A6.3).
- Fact sheet #6 Flight paths and aircraft sound was developed in response to community enquiries about flight paths related to the New Parallel Runway (see **Appendix A6.3**).
- Flight path and noise charts were tested in focus groups to determine their effectiveness in communicating where aircraft will fly and the noise this will cause. A number of changes have been made based on feedback from these groups to the charts to increase their readability and use.
- Due to community feedback related to flight paths, a separate Flight Paths and Noise Information Booklet will be produced for the public comment period.

6.6 The Public Engagement Program – Phase Two

Public comment period (31 October 2006 – 2 February 2007)

Phase Two of the PEP spans the period from 31 October 2006 to 2 February 2007. This begins at the release of the Draft EIS/MDP and includes the associated public comment period for the document. This phase focuses on refining and building on the engagement activities undertaken during Phase One to provide the community with information on outcomes from the Draft EIS/MDP through a range of engagement activities that maximise community reach. Phase Two is focused on providing information to and receiving feedback from the community.

A number of information requirements for the community were identified for this phase, including:

- Providing the Draft EIS/MDP for community viewing in a number of locations and formats.
- Providing a summary of the Draft EIS/MDP highlighting major outcomes and any proposed mitigation strategies under the designated four information categories.
- Explaining the public comment period timing and purpose.
- Answering questions about the Draft EIS/MDP.
- Explaining feedback processes for the Draft EIS/MDP.
- Explaining who to contact for further information related to the Draft EIS/MDP and the project.

Engagement tools to be utilised during Phase Two of the PEP include:

- Information sessions and public displays.
- Briefing sessions with updated Information kits.
- Freecall 1800 information line.
- Enquiry email.
- New Parallel Runway project website.

- Print advertising.
- Media activity.
- Draft EIS/MDP and supporting documents.
- Contact cards.
- Project DVD.

6.7 Conclusion

In its early planning for the New Parallel Runway project, BAC made a firm commitment to a public engagement process that commenced informing the community about the EIS/MDP process well ahead of the public comment period. BAC understands that much of the concern around large infrastructure projects is driven as much by lack of information or misunderstanding as it is by genuine objection from within the community.

BAC has actively engaged with the community for around 12 months ahead of the release of the Draft EIS/MDP for public comment. In this time BAC has endeavoured to reach and inform as many people across Brisbane as possible. BAC has extended the reach of its information to communities located as far as 15 – 20 km from the Airport and has taken into account areas from which complaints about noise have been registered.

The activities undertaken to date will be further supplemented by intensive engagement activities as part of the PEP for the EIS/MDP process.

The combination of activities before and at the time of the release of the Draft EIS/MDP will ensure that the broadest number of community members have been reached and given an opportunity to give feedback on this important public infrastructure project.
